CALL TO ORDER

Ms. Dobmeier called the meeting to order at 4:04 p.m. Ms. Dobmeier welcomed everyone to the meeting.

Report to the Buffalo State College Council September 26, 2017

Progress Report, Updates, and Significant Accomplishments Since the April 4, 2017 meeting. Prepared by: Kate Conway-Turner, President

It is my pleasure to welcome the members of the Buffalo State College Council to the 2017-2018 academic year. I trust that you all had a pleasant and restorative summer. We have had a busy yet very productive summer at Buffalo State. The landscape has changed both at Buffalo State and in SUNY since we were together last spring. Among the changes are:

A New SUNY Chancellor

Chancellor Kristina Johnson joined the SUNY family on September 5th. We received early communications from her as she reacted to some of the issues that we are facing as a country. In particular, she communicated about how SUNY might become involved in providing assistance to those in the areas that were impacted by the hurricane. And she has also communicated her concern regarding the repeal of the DACA legislation that provides some safeguards for children who have grown up in the United States with an undocumented status.

Chancellor Johnson visited Buffalo State in August and we were able to spend a few hours together discussing our institution. She seemed to be very impressed with our goal to be a nationally recognized Urban Engaged campus and the many ways we provide an excellent, engaged, and socially responsible education. She also had a short tour of campus. She seemed impressed with our new and renovated spaces and of course I shared with her the additional facility needs we have. It was a pleasure to introduce her to Buffalo State and to share with her both the shining stars and the needs of our campus.

Excelsior Scholarship

This summer thousands of Buffalo State students applied or were eligible for the much anticipated Excelsior Scholarship. The State has not aggregated information and made public the total number of students that applied and received funding through Excelsior nor have they provided the average award. This is information that should be forthcoming soon. Many are curious, including the media, of what the impact of the Excelsior Scholarship will be. What is clear is that the Excelsior Scholarship increased the discussion and consideration of those who were thinking about attending college and ultimately that is a good thing.

DACA Repeal

I am sure you have read about President Trump's repeal of the existing DACA (Deferred Action for Childhood Arrivals program) legislation and you may have seen the response from the higher education community, business leaders, and many politicians. I have also made a statement in my blog of September 8th <u>http://kateconwayturner.tumblr.com/</u>. This has unsettled the 800,000 young people who registered with DACA and many of our citizens and friends worldwide. We are hopeful that Congress will quickly develop a policy that will safeguard these individuals, but it is yet another unsettling moment for the country.

Opening of the Year Activities

We hosted many opening activities for every segment of our community the week before and the first week of classes. We welcomed first year, returning, residential, commuter, and graduate students to Buffalo State College. We held a convocation and invited recent alumni to share their stories with new students. We held orientation sessions for new faculty and staff. We had student picnics, student get togethers, a staff Corn Fest, and a UUP BBQ. So we have come together in multiple and varied ways to remind us that we are here for each other and that the semester has started.

Organization Realignment and Leadership Changes

We are starting the year with several new organizational realignments in place that will better serve our students and better allow us to meet our goals. All changes have been announced to the campus community and the units impacted have been made aware of the changes. We will continue to communicate to the campus community changes as they are finalized. Dr. Jim Mayrose has been appointed as Interim CIO and Vice President for Enrollment, Marketing and Communication following the resignation of Dr. David Demers over the summer. Dr. Demers took a position in Maine as System CIO. A search will be opened this fall to replace Dr. Demers on a permanent basis.

We are moving along with the search for Vice President of Student Affairs. Four candidates have been invited to participate in interviews with various campus constituent groups beginning in mid-October. The members of the Student Affairs Committee of the College Council will have an opportunity to meet these candidates.

Charles Kenyon, associate vice president for student affairs and dean of students at Buffalo State retired last semester after twenty-five years of dedicated service. Sarah Young, director of student life, has been appointed interim dean of students, reporting to the interim vice president for student affairs. The Student Life and Judicial Affairs offices will report to Ms. Young in her role as interim dean of students. A search for a permanent dean of students will begin soon.

Enrollment

As of the freeze file date of September 16, we had 1830 full time first year students and 826 new full time transfer students enrolled at the college. These numbers are slightly up from this time last year. It was especially good to see the gain in transfer students and part-time students, areas where we had seen decreases last year. We also saw a decrease in new graduate students, but an increase in returning graduate students. With our continuing student population remaining about the same as last year, we began the Fall semester with 9596 total students. Overall, this is a positive enrollment picture for the campus.

On retention levels, the college introduced many retention efforts across campus. These efforts are seeming to have a positive impact and we will continue to follow and assess them. This focus on retention and completion is the new normal for our campus. We will continue to focus our energy on student success, completion, and roaring in 4.

We have 2460 students assigned to on campus housing. We have accommodated all students without the renting space from other nearby local colleges and none

of our freshman are living in triple occupancy rooms. The opening of the private Campus Walk and changes in housing policy allow the campus to meet the needs of current students which results in 300 less students in formal campus housing. This reduction is desired to provide a superior experience for our student population.

Budget Update

You received a preliminary update from me on September 7th regarding our current budget situation. A full budget update will be provided during the meeting on October 3rd.

Bengals Dare to Care Day

Our annual Bengal Dare to Care Day was a tremendous success this year. We closed registration this year at 1050 students, faculty, staff, administrators, alumni and friends of the college. This was our largest group to date. On September 16th, members of the campus community provided service at 35 community sites and organizations. From urban garden cleanup to spreading mulch at parks to restoration projects, we lent our energy to improve the City of Buffalo.

At its October 3, 2017 meeting, the Buffalo State College Council recommended; and President Conway-Turner approved; that the Patio of the Jacqueline Vito LoRusso Alumni House and Visitor Center be named in honor of Karen '69 and Richard Penfold.

A native of Alden, NY, Karen Kostecky, enrolled at Buffalo State in 1965 and completed her degree in Elementary Education in 1969. She married Richard Penfold one week after she graduated from Buffalo State. The Penfolds spent a year in Germany, where Richard was stationed with the U.S. Army. When they returned, they joined Aurora Sanitation, owned by Richard's father. After several years, they formed their own company, C.I.D. and operated it until selling it in 1998.

A long-time supporter of Buffalo State, Karen served on the Buffalo State College Foundation Board of Directors and was a member of the Planned Giving Committee. She received the Buffalo State College Foundation Chair's Recognition Award in 1996 for extraordinary volunteerism, was Buffalo State College Foundation's Distinguished Honoree in 1996 at the National Society of Fund Raising Executives Western New York Chapter, the Buffalo State College Quasquicentennial Philanthropic Award in 1997, and was recognized as a Distinguished Alumna in 2009.

She also served on countless civic and community organizations, including president of the WNY Council of the American Heart Association and chaired the 2001 Buffalo and Erie County Historical Society Electric Ball. She has received many awards recognizing her volunteerism, including the Elaine M. Mack Community Service Award, from Hopevale, Inc. (1999), the Mater Christi Award from Immaculata Academy (1998), the Imagine Canisius Award from Canisius College (1998) certificates of appreciation from YMCA,(1994) and the Treemor Neighborhood Girl Scouts (1992), the Buffalo Philharmonic Orchestra's Woman of the Year (2002), and the National Federation for Just Communities of WNY Citation Award for community service (2014).

Karen and Richard were recognized as Philanthropists of the Year (1999), and received the Sister Mechtilde Memorial Award from Kenmore Mercy Foundation (1996), the Trocaire College Reflections Award for the Year (2001), and the Pioneer Investors Award from Buffalo and Erie County Historical Society (2001).

Past chair of the Buffalo State College Council, Mr. Zemsky's energy and commitment have helped guide the school through a number of successes and transitions. He led the search process for the college president following Dr. Howard's departure. He has also chaired the Scholarship Gala, advisory committees and other college initiatives.

Mr. Zemsky influence extends to the state level as he plays a significant role in the shaping of Gov. Andrew Cuomo's plan to invest \$1 billion of state incentives in the Buffalo-area economy. He is managing partner of Larkin Development Group, the firm that redeveloped the historic Larkin District in Buffalo into a mixed use commercial, residential and retail district, serving as a catalyst for the revitalization of the surrounding neighborhood.

He's also active in the civic and preservationist community. Governor Cuomo appointed Howard Zemsky chairman of the Niagara Frontier Transportation Authority, he served as president of the Richardson Center Corp., charged with restoring that historic property, and also serves on the boards of the Martin House Restoration Corp., the Michigan Street Preservation Commission and Buffalo Place.

Mrs. Zemsky currently serves on the Buffalo State College Council. She is the recent past Board President of the Buffalo Fine Arts Academy, governing body of the Albright-Knox Art Gallery. During her tenure, she worked with the entire board and former Albright-Knox Director Louis Grachos on developing the museum and its Collection, not only as a world-renowned venue and a magnet for Buffalo Niagara tourism and economic growth, but also as a vital community resource for educational, artistic, and creative experiences. She also oversaw the hiring of the Albright-Knox's 11th director, Dr. Janne Sirén, following Grachos's departure at the end of 2012.

Leslie is a board member of Visit Buffalo Niagara, was a board member and founding chair of Advancing Arts and Culture Buffalo Niagara, a past trustee of the Erie County Cultural Resource Advisory Board, the Community Foundation for Greater Buffalo, and Nichols School, and past board chair of Elmwood Franklin School. Her energy and community focus serves her well as Director of Special Events and Projects for the Larkin Development Group, where she will continue to make sure "Larkinville" remains a destination for all.

The Zemsky's support is not only through their leadership, but also their philanthropic investments in campaigns across the region. They were part of the launch of the Burchfield Penney Art Center, as leading contributors toward a challenge grant. Their commitment to Buffalo State continues, as they have pledged a substantial gift to make the alumni house a

Academic Commons, Butler Library
This project will reconfigure parts of Butler Library to accommodate the Academic Commons, a "one stop shop" for academic support including tutoring, advising, writing assistance and student accessibility services. This \$10.4 million project is currently in the planning and design phase.
 Caudell Hall Renovation
This project has renovated spaces for the Hospitality and Tourism; Health, Nutrition and Dietetics; Social Work; and Speech-Language Pathology departments. Classroom, lab and office spaces have been renovated, and the building exterior has been refurbished. This \$21.2 million project was completed in fall 2016 and the building opened for classes in January 2017.
Science and Mathematics Complex, Phase 3
In this multi-part project, phase 1 construction provided a multi-story glass atrium, an advanced imaging suite, and state-of-the-art research and teaching facilities for the biology, chemistry, earth science and science education departments, as well as the Great Lakes Center.
During phase 2 the north wing of the existing Science Building was renovated to house classrooms, labs and offices for departments in the sciences at a cost of \$30.9 million.
During phase 3 the south wing of the Science Building will be demolished and replaced. The new south wing will include a planetarium, a greenhouse, labs, classrooms and lecture halls. The cost for this phase will be \$35.5 million, with construction planned from fall 2017 to spring 2020.

Athletics Projects: Sports Arena and Coyer Field
Athletics facilities improvements include installing lighting at Coyer Field; resurfacing the outdoor running track; renovating the Sports Arena locker rooms; and replacing the indoor track and the telescopic bleachers in the Sports Arena. At a total cost of \$3.2 million, these renovations will be completed in fall 2017.
Buckham Hall B-Wing
This project has fully renovated a previously unoccupied wing of Buckham Hall to house departments moving out of Bishop Hall. (Bishop Hall will be returned to use as a student residence.) Office and lab spaces have been created for the Communication, Modern & Classical Languages and Philosophy Departments; and for Research Foundation/Sponsored Programs staff members. Completed in spring 2017, this project cost \$8.2 million.
Jacqueline Vito LoRusso Alumni and Visitor Center
This new building, approximately 10,500 square feet in size, will provide offices, reception space and meeting space for the Alumni Affairs and Admissions offices. It will serve as a visitor center and starting point for tours and other special events. Construction began in spring 2017 on this \$5.45 million construction project.
Central Heating Plant Reconstruction
Buffalo State's current steam plant is at the end of its life cycle. This project will replace boilers and all associated equipment with new and more efficient versions. This will reduce costs for fuel, operation and maintenance; reduce harmful emissions and the potential for harmful fuel leaks; and provide a more reliable source of heat and hot water for the campus. This \$20.8 million project will begin in fall 2018.
Bishop Hall
This project will return Bishop Hall to its original use as a residence hall for first-year students. The building will be reconverted to a 204-bed corridor-style residence hall with kitchen, study, lounge and recreation spaces distributed throughout. Renovations will create restrooms with privacy and update the building's mechanical, electrical, plumbing and fire safety systems. This \$16.1 million project is funded through the Dormitory Authority of the State of New York (DASNY). Completion is planned for summer 2018.
