CALL TO ORDER

Mr. Hoskins called the meeting to order at 4:05 pm.

ACTION ITEMS

Mr. Hoskins requested approval of the minutes from the April 29, 2008 meeting. Mr. Zemsky made the motion that the minutes be approved; Mr. Brandys seconded the motion. Mr. Hoskins requested the approval of the 2007- 2008 Annual Report. Mr. Brandys made the motion that the Annual Report be approved; Ms. Brosnahan seconded the motion. Both motions were approved by unanimous vote.

CHAIR'S REPORT

Mr. Hoskins informed the council that Governor Paterson has reappointed Howard A. Zemsky to the Buffalo State College Council for a term to expire June 30, 2015. Mr. Hoskins congratulated Mr. Zemsky and thanked him for his involvement to the College. Mr. Hoskins asked the council to congratulate Alphonso O'Neil-White for being named "Business Executive of the Year" by Richard J. Wehle School of Business at Canisius College. Mr. Hoskins also introduced the student elected representative to the Buffalo State College Council for 2008-2009, Ms. Dominique Gabriel. She is senior majoring in political science and minoring in public administration. In addition to her role on the college council, she also serves as the president of the United Students Government, a college senator and a member of both the Grant Allocation Committee and the Faculty Student Association. The council welcomed Dominique and she delivered her report (see attached).

PRESIDENT'S REPORT

President Howard delivered her executive report (see attached). She reported on the status of the state budget. The college was notified of a 4th reduction for 2008-2009 bringing the total reduction for Buffalo State College to \$2.2 million dollars. She asked the council to be prepared to assist the college by supporting rational tuition and new flexibility policies. She indicated that we was should have more definitive information on the budget after the Governor's meeting with the legislature on November 18th.

Vice President Payne provided an update on enrollment (see attached). Vice President Payne recognized the efforts of Mark Petrie and Tim Ecklund and the admissions and orientation staff with recruitment for 2008-09. Mr. Brandys commented that the college has made some excellent changes in the recruitment and retention areas and he commended the admissions department for doing a great job.

Provost Dennis Ponton introduced Mark Severson, the new dean of School of Natural and Social Sciences and Scott Johnson, Interim Dean, for University College. Dr. Ponton provided a report on the Research Foundation (see attached). Dr. Ponton reported that the college is working through the process a new Strategic Plan 2009-2014. Much of the previous plan will still continue to support Buffalo State College. Buffalo State College is also working on the National Survey NSSE benchmarks (see attached).

COMMITTEE REPORT

Naming of Building & Grounds

Ms. Laurie Brosnahan delivered the report of the Naming of Building and Grounds Committee recommending approval of the naming of a conference room in Cleveland Hall in honor of Dr. Carmine Grande (see attached). Ms. Brosnahan called for the motion. Mr. Brandys seconded the motion. The motion carried unanimously.

Student Affairs

Mr. James Brandys delivered the report from the Student Affairs Committee. Mr. Brandys reported the artificial turf on Coyer Field was completed at the end of July and it was a great addition for students and athletes. The residential dinning renovations are complete and it's great for the college community, and to see all the faculty members dining there. Vice President Payne reported said that the renovations of the union lobby and Social Hall will be started in 2009 and the quad will be completed by fall 2010. Mr. Brandys reported that new student housing will be needed over time to accommodate about 400 students; and this issue will be reviewed at the later date.

He also presented and recommended approval on a resolution to increase parking fines (see

attached).

Mr. Naughton moved for approval; Mr. Zemsky seconded the motion. The motion carried

unanimously.

ANNOUNCEMENTS

Mr. Hoskins encouraged all to join the members of the college council on the fourth floor of

Cleveland Hall immediately following the meeting to officially name the conference room in

memory of Carmine Grande, former Vice President for institutional advancement at Buffalo State

College. Carmine is fondly remembered at Buffalo State and the council is pleased to be able to

help pay tribute to his memory.

EXECUTIVE SESSION

Mr. Hoskins called for a Vote to Move to Executive Session: In accordance with Section 105 of

the New York State Open Meetings Law. Mr. Zemsky moved that the council move to execute

motion be approved; Mr. Brandys seconded the motion. The motion carried unanimously. The

council adjourned to executive session.

ADJOURNMENT

After the executive session ended the council reconvened to open session. Mr. Hoskins called for

a motion to share the discussions in executive session with the Buffalo State College Foundation.

Mr. Zemsky moved for approval. Mr. Brandys seconded the motion and carried unanimously.

Mr. Hoskins the called for a motion to adjourn the meeting. Mr. Zemsky moved for adjournment

and Mr. Naughton seconded. The meeting was adjourned at 6:10 p.m.



Introduction

The 2008-2009 academic year is off to an excellent start with many new and exciting developments at Buffalo State College. We welcomed nearly 1,600 new freshmen, one of the largest classes in recent history, to campus in August. The total enrollment for Fall 2008 is approximately 11,300 students. I am also pleased to advise you that Buffalo State is one of 22 SUNY institutions hosting students from the Sichuan Province of Western China, the site of a massive earthquake this past May. We have 17 students, primarily sophomores and juniors, enrolled in classes. They will study for two semesters as full-time students at Buffalo State. Each student has committed to engage in national service projects in Sichuan to help with the rebuilding effort when they return to their home country in June 2009.

The demand for on campus student housing has continued to increase, which is consistent with national trends in student housing. As of September 30th, there are 2,312 students living in college housing, an increase of 174 students from last year at the same time. This demand has resulted in an increase in three-person rooms (triples) in the freshmen residence halls and 143 transfer students are being housed at the Adam's Mark Hotel in downtown Buffalo. Transportation and other necessary services have been expanded to the Adam's Mark to ensure that the students living there are well connected to the College.

Administration and Faculty

Dr. Mark Severson joined the Buffalo State family as the new dean of the School of Natural and Social Sciences in September. Dean Severson comes to us from Oakland University in Rochester, Michigan, where he was professor and chair of chemistry. Dr. Scott Johnson has been appointed as the interim dean of University College. Dr. Johnson, an associate professor of criminal justice, has served as the assistant dean for first-year academic programs and academic support in University College since its inception in 2004.

We are also delighted to welcome a record number of new faculty members, nearly 50, to the Buffalo State community. These new professors, come to us with excellent credentials from fine and far reaching institutions and represent a wide range of academic disciplines. A listing of our new faculty is included with this report for your information and review.

Campus Ceremonies and Events

The college community celebrated the start of the 2008–2009 academic year at the annual Academic Convocation on September 25th. Six members of the Buffalo State community who have distinguished themselves through their teaching, scholarship, and service were recognized with the 2008 President's Awards for Excellence. Jill K. Singer, professor of Earth Science and Science Education and Director of the Office of Undergraduate Research received the Chancellor's Award for Excellence in Scholarship and Creative Activities.

State University of New York Trustee Gerri Warren-Merrick joined us to confer the SUNY honorary degree on author Lorene Cary. Dr. Cary delivered the Vern and Bonnie L. Bullough Convocation Address. She is senior lecturer in creative writing at the University of Pennsylvania. A noted author, educator, and community advocate, she began her writing career at *Time* in 1980 before working as an associate editor at *TV Guide* and as a contributing editor for *Newsweek*. Her work has been published in *Essence*, *O Magazine*, and *Mirabella*. In addition she has published four books. Cary's talent has been recognized with a Pew Fellowship in the Arts and a writing fellowship from the Leeway Foundation, and by residencies at Yaddo in New York and at the Civitella Ranieri Center in Italy.

The Buffalo State College Foundation hosted the 11th annual Golf and Tennis Scholarship Classic on Monday, September 8, at the Brookfield Country Club in Clarence, New York. BlueCross BlueShield of Western New York was the presenting sponsor of this year's annual event. The event raised \$75,000 to support the All College Honors Program.

Seventeen new members were inducted into the Peterson society this year at the annual Peterson Society Dinner on September 17th at the Buffalo Club, bringing the total membership to 230 members.

The college hosted Homecoming/Parents Weekend and Fall Open House activities from September 18th through 21st. Five Buffalo State graduates were honored as Outstanding Young Alumni and five former student athletes were inducted into the Athletic Hall of Fame.

As with every year, our focus will primarily be on the academic progress of our students. However, the current economic climate of the country and the state will have a dramatic impact on our ability to deliver the academic and support services that we believe are essential to our students' success. To that end, we will continue with the development and implementation of the next five-year strategic plan in an effort to prioritize the institutions' goals and to provide a strategy to utilize our resources in the most effective manner.

State Appropriated Budget and Revenue

There is very little to report with certainty on the state budget except that we are expecting additional budget reductions and spending restrictions on top of those already imposed over the summer. We do not expect to have any more definitive information until after the elections. The SUNY Board of Trustees' Finance Committee, SUNY Trustees Chairman Hayden and Jim VanVoorst, SUNY Vice Chancellor for Finance, have been working with a group of SUNY presidents and business officers, respectively, in preparing a response to the latest round of state budget reductions to the State University. I have attached the talking points to this report for your information. They address such strategies as (1) The State of the University, (2) The Need to Deregulate SUNY, and (3) Expanding Entrepreneurial Activities and Greater Flexibility to Divest Assets.

Facilities

Many of you had the opportunity to see some of the capital and facilities projects that were completed over the summer which included several classroom and laboratory renovations. The new residence dining center was opened in August in time for the beginning of classes. The turf on Coyer Field was replaced proving a new playing surface for four of our athletic teams (football, men's and women's soccer and women's lacrosse). And the new Burchfield

Penney Art Center was completed and turned over to the college on September 5th. The public opening of the center will occur on November 22nd. Plans for remodeling of the Science and Mathematics Building and the construction of the Technology Building are on target. We are also developing a process and structure by which the college can build a new residence hall and the construction of a new athletic stadium is still a priority.

The Music Department and Art Conservation facilities will expand into the third floor of Rockwell Hall when the Burchfield-Penney Art Museum moves into its new building. Music will acquire a 150 seat recital hall, and Art Conservation will use the existing humidity-controlled storage rooms to add a library and a conservation lab. Both of these departments recently received national accreditation in recognition of excellence of their programs, faculty, students and facilities.

Technology Update

Phase I of the BANNER System implementation has been completed. BANNER is now the official system of record for all students, handling all of our student service modules, Admissions, Financial Aid, Student Accounts, Registration, Grading, and provision of transcripts. The short term focus is now on addressing individual department and specialized reporting needs, addressing any outstanding user issues, and working with faculty and staff to prioritize user-requested enhancements. With the initial implementation tasks largely out of the way, we can now start to think about leveraging our investment in Banner.

Upcoming Campus and Community Events

October is National Arts and Humanities Month, which grew out of National Arts Week, begun in 1985 by the National Endowment for the Arts and Americans for the Arts. It evolved into a month-long activity in 1993 and is now the largest national celebration of the arts and humanities in America. Every October, the Buffalo State College campus community joins the nation in organizing the College's annual month-long celebration. College events include student and faculty musical performances, theatrical productions,

poetry and dramatic readings, art exhibitions, panel discussions, lectures, demonstrations, and special exhibitions. A complete listing of activities for the month can be located on the Buffalo State College website at


Chinese musicians from Capital Normal University in Beijing will be on campus on October 27, 28, and 29 for presentations and performances. We cordially invite you to participate.

New Students




Spring enrollment is down 281 students from 2007 at the start of the fall registration period. Despite the lower starting point, we are up 539 registered students from the same point last year.







SPONSORED PROGRAMS EXPENDITURE SUMMARY PROFILE

Year Ended June 30, 2008



Sponsored programs administered by the Research Foundation of State University of New York generated \$784 million in expenditures during fiscal year 2007-08, which ended June 30, 2008. Direct expenditures totaled \$659 million; indirect expenditures were \$125 million.

This document provides a schedule that displays the five-year trend of total sponsored programs expenditures by campus (page 1).

The document also provides three different views of the fiscal year 2007-08 sponsored programs expenditures:

- By campus within major category of expense: salaries, fringe benefits, equipment, subawards, other direct and indirect (page 2).
- industry and other, within major category of expense: salaries, fringe benefits, equipment, subawards, other direct and indirect. Sponsors • By funding source: federal, federal through nonfederal other, federal through nonfederal New York state, New York state and business, with less than \$1 million in expenditures are not displayed individually; they are grouped into "other" (page 3)
- By program type within major category of expense: salaries, fringe benefits, equipment, subawards, other direct and indirect. Program types are defined by the National Association of College and University Business Offices (NACUBO) funding categories. Requested Action of the Buffalo State College Council at the October 14, 2008 Meeting

To adopt a resolution approving amendments to the Traffic and Parking Regulations for Buffalo State College, Section 562 of the New York State Education Law.

Background:

- The college's Traffic and Parking Regulations were last amended January 2000 (the previous amendment was June 1990)
- Need to update to reflect administrative changes that have occurred since the last amendment date such as:
 - correcting name of Public Safety to University Police
 - correcting the name of Traffic Office to Parking Services
 - Lot G designated for student, faculty, and staff use 24 hours a day
 - Correct "handicapped" terminology to "persons with disabilities"
 - Correct "director" of Public Safety to "chief" of University Police
- Need to increase fines for violations of the parking rules.
 - Current fine for most violations is \$15.00 (\$50.00 for handicapped space, \$25.00 for firelane, \$25.00 fire hydrant)
 - \$15 no longer deters people from violating the college's parking regulations
 - New fines will be
 - \$ 25.00 for most parking violations.
 - \$ 35.00 for violation of a fire lane or fire hydrant.
 - \$50.00 for violation requiring an intracampus tow.

Note the fine for violation of a handicapped designated space will remain at \$50.

Process to Change Section 562 of the Education Law:

- July 2, 2008 the Notice of Proposed Rule Making was published in the State Register by the Department of State for the mandated 45-day public comment period.
- August 16, 2008- Public comment period expired without comment.
- October 14, 2008 Submission to Buffalo State College Council for approval of amendments.
- November 2008 SUNY Counsel files Notice of Adoption for publication in the State Register.
- November December 2008 Publication in the New York State Register and amendments become effective.

Notice for the Record, Daily and Bulletin:

Parking Violations Fines to Increase January 1, 2009

Effective January 1, 2009, fines for parking violations on campus will increase from \$25 for violation of a fire lane or fire hydrant, and \$15 for all other violations to \$35 and \$25, respectively. For violations requiring an intracampus tow (from a lot where parking is prohibited from 1-6a.m. to lot F, M-2, R or G), the penalty shall be a \$50 fine. This fine is in addition to a fine violation of \$25 for violation of parking in a no parking 1am – 6am parking lot. The fine for violation of a parking space designated for persons with disabilities will remain at \$50.

Parking fines not paid or appealed within 30 days of receipt of the summons are doubled. Students who have outstanding parking fines are barred from registering for class or receiving their transcript. Employees who have outstanding parking fines for more than 90 days will have the fines deducted from their paychecks. Vehicles parked on campus with outstanding parking fines are subject to either towing or the placement of an immobilization boot on the vehicle.

§ 562.1 General statement of policy.

The operation of a motor vehicle on the property of the State University College at Buffalo is covered under section 360 of the Education Law, which authorizes the State University to adopt and make applicable to its campuses any and all provisions of the Vehicle and Traffic Law. The following regulations have been developed and are enforced to provide for the safety and convenience of students, faculty, employees and visitors upon the State University College at Buffalo campus. (Notice: The regulations are strictly enforced 24 hours a day, seven days a week, 12 months a year.)

§ 562.2 Registration.

(a) No person, including students, members of the faculty or staff, shall park a motor vehicle, motorcycle or moped of any kind or description on premises or property under control of the State University College at Buffalo unless such motor vehicle, motorcycle or moped is properly registered with the college. Personnel employed by off-campus agencies who are assigned to the college as a regular work location should also register their vehicles and comply with all motor vehicle regulations.

- (b) A registration decal will be issued and must be affixed to the vehicle in accordance with instructions in section 562.3 of this Part. Upon completion of the vehicle registration form and payment of the required fee(s), a registration decal shall be issued.
- (c) Such registration shall be valid as indicated by the expiration date on the registration decal, and shall be conditioned upon remaining enrolled at the college if a student, or upon continued employment at the campus if a faculty or staff member or other person assigned to or using campus facilities.
- (d) A registration fee, as approved by the chancellor, or designee, shall be charged for each motor vehicle registered and for all replacement decals.
- (e) Faculty, staff and students are required to produce an official college identification card and a vehicle registration in order to obtain a permit. There will be no exceptions to this rule. All others, such as campus visitors and/or guests, should be prepared to show vehicle registration and a personal driver's license when obtaining a permit.
- (f) A person may register more than one vehicle if for his or her specific use on campus. Exceptions to this rule will be authorized only by the director of student accounts or designee.
- (g) No person shall provide any false or misleading information, whether by act or omission, when applying for any registration or permit pursuant to this Part, or when otherwise required or requested by a college official to provide information concerning the operation or parking of a vehicle on the campus premises and grounds.
- (h) Falsification of information to obtain a permit will subject the offender to disciplinary actions and/or arrest.
- (i) There must be no unpaid college imposed parking fines or penalties outstanding against the applicant or the vehicle registered before obtaining a parking permit.

§ 562.3 Permits.

- (a) Parking on campus is by permit only. Only those motor vehicles properly displaying a valid permit are authorized to use campus parking areas.
- (b) The permit shall be affixed to the vehicle in accordance with the printed instructions on the permit. A vehicle may not display more than one permit at a time.
- (c) Failure to display a permit or the improper display of a permit will constitute a violation. Permit must be in sight and numbers must be unobstructed.
- (d) Parking permits are not transferable from the individual to whom they are issued to any other individual. Permits are not transferable from one vehicle to another.
- (e) Parking permits must be removed from vehicles under the following conditions:
 - (1) change of ownership of vehicle:
 - (2) termination of association with the college;
 - (3) termination of authorized period for which issued: or

- (4) receipt of permit which supersedes a prior permit.
- (f) Mutilation, theft or other disposition must be reported promptly to the [Department of Public Safety] university police department.
- (g) Should a permit become mutilated or obliterated in any way, a new permit must be obtained from the student accounts office. Evidence of the mutilated permit must be presented for replacement. A fee, as approved by the chancellor, or designee, shall be charged for any replacement permit.
- (h) A "STAFF" parking permit shall be issued to:
 - (1) all full-time employees of the college;
 - (2) personnel employed by off-campus agencies who are assigned to the college as a regular work location for a period of one year or more;
 - (3) faculty emeriti;
 - (4) part-time employees who are not students at the college;
 - (5) graduate assistants; and
 - (6) adjunct faculty.

Staff parking permits are valid in all staff and student/staff lots. Under no circumstances shall a faculty or staff member register a motor vehicle owned, operated or controlled by a student. Student use of staff parking permits is prohibited, and such violation will result in tagging and towing or immobilizing of the vehicle.

- (i) A "TEMPORARY" parking permit may be issued to persons:
 - (1) visiting the campus;
 - (2) using space on the campus but not associated with college programs and activities:
 - (3) disabled by injury or illness, as determined by the [traffic] <u>parking services</u> office (see section 562.10[d] of this Part);
 - (4) employed by contractors working on campus; or
 - (5) employees or students who have paid the registration fee for that academic year.

Student use of temporary parking permits in staff or visitor lots or in lots/spaces other than student lots is prohibited, and such violations will result in tagging and towing or immobilizing of the vehicle.

- (j) A "STUDENT" parking permit may be issued to all registered students. The following are included in this category:
 - (1) USG student employees:
 - (2) resident assistants; and

(3) student employees.

Student parking permits are valid in student lots only.

- (k) An "ADMINISTRATION" parking permit shall be issued to all management/confidential personnel and others designated by the Vice President for Finance and Management. These permits are valid in the designated lots and all staff and student/staff lots.
- (I) New York State ["HANDICAPPED"] municipal parking permits for persons with disabilities are not issued by the college. The college does, however, honor all municipal [handicapped] parking permits for persons with disabilities. Staff and students with [handicapped] municipal parking permits for persons with disabilities may not park in designated visitor's lot or any other special designated reserved parking spaces. Only persons with municipal parking [handicapped] permits for persons with disabilities may park in areas designated [handicapped] spaces for persons with disabilities. Persons who possess a valid New York State [handicapped] license plate for persons with disabilities or a valid permit issued by a municipality in accordance with the New York State Department of Motor Vehicles [G]guidelines for [the Physically Handicapped] persons with disabilities may park in [spaces] areas designated ["handicapped parking only."] for persons with disabilities. All vehicles parked on campus also must display a valid Buffalo State College parking permit.
- (m) A "VENDOR" parking permit shall be issued to all vendors required to service college facilities and operations. Vendor permits are valid in Cleveland Hall Circle load zones for one- half hour maximum, or in any staff or student/staff lot.
- (n) A "GENERAL RESERVE" parking permit shall be issued to individuals designated by the Vice President for Finance and Management and is valid in specifically designated areas of lots D and D-2 or in any staff or student/staff lot.
- (o) Vehicle permits and/or replacements will be provided only after the appropriate fee, as approved by the chancellor, or designee, has been paid.

§ 562.4 Parking lots.

- (a) Parking fees as approved by the chancellor, or designee, shall be charged for motor vehicles parked within designated lots, consistent with applicable collective bargaining agreements and in accordance with guidelines established by the chancellor or designee. Such guidelines shall provide that the determination of the amount of the fee be substantially based on an analysis of the costs attributable to the operation and maintenance of the parking facilities owned and operated by the College at Buffalo.
- (b) No person shall park a vehicle in any area except those areas specifically designated as motor vehicle parking lots or spaces. Where campus parking areas have been designated respectively for students, staff or visitors, as the case may be, no motor vehicle shall be parked in a designated parking area other than the parking area to which such registrant or visitor has been assigned. Special parking provisions may be granted in extraordinary circumstances by the [director of public safety] university police chief or designee.
- (c) All lots designated A, B, D, F-1, H, S-1, T and U are for staff and faculty use only, between the hours of 6 a.m. and 4 p.m., Monday through Sunday. Student use of these lots is permitted from 4 p.m. to 1 a.m., Monday through Sunday. Lot W is designated for staff and faculty use only between the hours of 6 a.m. and 5:30 p.m., Monday through Sunday.

(

- (d) All lots designated S and S-2 are for faculty and staff use only between the hours of 6 a.m. and 1 a.m. Student use is not permitted at any time in prohibited areas such as Upton East, Bacon Lot, Bengal Mall or areas designated specifically for [public safety] <u>university police</u>, maintenance or any other specific designation.
- (e) All lots designated A-1, F, G, L, L-1, M, M-1, M-2, R and Z are for student, faculty and staff use between the hours of 6 a.m. and 1 a.m.
- (f) All lots designated F, G, M-2 and R are for student, faculty and staff use 24 hours a day.
- (g) Lots C, L-2 and X are restricted for individuals paying for metered spaces.
- (h) Lot Y is restricted for persons displaying a student parking permit.
- (i) Lots D-1 and E is restricted for persons displaying an ADMINISTRATION OR GENERAL RESERVE parking permit.
- (j) All lots designated MP are for motorcycle and moped parking only. Motorcycles and mopeds may also park in lots A and A-1.
- (k) Faculty, staff and students are prohibited from parking in any areas not specifically designated for their use.
- (I) For the purposes of snow removal, repair and maintenance of lots and roadways, no parking will be allowed on roadways or in parking lots from 1 a.m. to 6 a.m. except where specifically designated by a sign for overnight parking.
- (m) Metered spaces on campus are for use by visitors to Buffalo State College. Parking at the meters is restricted to a maximum of two hours at a fee as approved by the chancellor or designee. Any parking beyond the stipulated maximum will constitute a violation regardless of time remaining on the meter. Parking at a meter indicates acceptance of the meter regulations.

§ 562.5 Driving and parking regulations.

- (a) No person shall drive a vehicle on college streets, roads or highways at a speed greater than is reasonable and prudent under the conditions and having regard to the actual and potential hazards then existing. The maximum permissible speed is 25 miles per hour on all roadways of the college.
- (b) All persons shall observe and obey any slow, stop, yield, caution signs or any other duly posted signs regulating traffic or parking.
- (c) The directions and requests of [campus public safety] university police officers shall be followed at all times.
- (d) No person shall park a vehicle on the premises of the university in such manner as to interfere with the use of a fire hydrant, fire lane or other emergency zone, create any other hazard or unreasonably interfere with the free and proper use of a roadway or pedestrian way, walkway, driveway or parking area. Specifically, no parking is permitted:
 - (1) on campus roads, except where specifically designated by a sign for parking;
 - (2) on sidewalks, walkways and pedestrian areas;

- (3) on lawns or grounds;
- (4) in load zones;
- (5) in any area other than those clearly designated as parking space and as indicated by posted signs, pavement markings or painted lines restricting or limiting such parking;
- (6) in parking lot aisles, entrances or exits; or
- (7) on or over painted parking lines.
- (e) Any area of the campus that has been closed off by the use of barricades or other traffic control devices shall not be entered by any vehicle except those authorized by [the department of public safety] university police department
- (f) Responsibility for finding appropriate parking space rests with the motor vehicle operator. Lack of space is not an excuse for illegal parking.
- (g) Any accidents should be promptly reported to the [public safety office] university police department, Chase Hall, [Room 127,] extension 6333.

§ 562.6 Motorcycles and mopeds.

Parking for motorcycles and mopeds is prohibited anywhere on campus except the designated motorcycle parking areas located in lots D and S-1 and in lots A and A-1. Motorcycles and mopeds parking anywhere else will be tagged.

§ 562.7 Towing and immobilizing.

The [public safety] <u>university police</u> department may authorize the towing away or immobilizing of vehicles parked in violation of the rules and regulations of the college. Any expense involved in removal or immobilization of vehicles, such as towing and storage charges, will be the responsibility of the owner of the vehicle. <u>Fines for intracampus tow violations will be in addition to fines for violations issued for no parking 1am – 6am when the vehicle must be moved for the purpose of snow removal.</u>

§ 562.8 Abandoned vehicles.

Abandoned vehicles will be dealt with by the [public safety] university police department and disposed of according to the New York State Vehicle and Traffic Law, section 1224.

§ 562.9 Enforcement of rules and regulations.

The [public safety] <u>university police</u> officers of the college have been empowered to enforce traffic and parking rules and regulations. Tickets will be issued to all vehicles which are not registered with the college and to vehicles which are in violation of campus parking and/or traffic regulations.

§ 562.10 Temporary parking permits.

(a) In the case of special visitors and/or groups of visitors (i.e., conference participants), appropriate arrangements can be made for temporary parking privileges. Applications must be made in advance with the events management office or the [traffic office] parking services office.

- (b) Staff or students using a vehicle other than those registered must obtain a temporary parking permit from the [traffic office] parking services office.
- (c) Personal guests of any staff or student must obtain a temporary parking permit at the [traffic] <u>parking services</u> office which will authorize parking in a specific parking area.
- (d) Persons whose physical infirmities necessitate special consideration may obtain a temporary MEDICAL parking permit valid in any staff or student parking area for a period of time not to exceed two weeks. Any person with a medical condition exceeding this period of time will be encouraged to apply for a municipal [handicapped] persons with disabilities parking permit if a resident of New York State. Certification of need must be obtained from the person's physician and submitted to the director of [public safety] parking services, or designee, for consideration and appropriate action. Medical permits are not valid in any legal handicapped space on campus.

§ 562.11 Maintenance, special events and emergencies.

- (a) Instructions relative to temporary parking restrictions to facilitate snow removal, cleanup, maintenance and repair will be forthcoming from time to time from the [department of public safety] university police department as the need arises.
- (b) On special occasions and emergencies, parking restrictions will be regulated by the [public safety department] university police department as required.
- (c) For certain college events, parking may not be limited to parking lots. Specific roads and/ or areas not otherwise used for parking may be designated for parking by the [department of public safety] university police department.

§ 562.12 Inoperative vehicles.

- (a) If a vehicle becomes inoperative for any reason and it is parked in violation of this Part, it is the responsibility of the owner/operator to make immediate arrangements to remove it. Vehicle breakdowns may not be accepted as an excuse for being illegally parked.
- (b) Storage of inoperative or damaged vehicles or those not displaying registration plates in campus parking lots is prohibited, except as specifically permitted by the [director of public safety] chief of university police.

§ 562.13 Security.

- (a) The college assumes no responsibility for automobiles and/or their contents.
- (b) Vehicles should be kept locked at all times. Valuables should not be left in sight on the seat but locked in the trunk.

§ 562.14 Changes or special instructions.

- (a) Any change of rules, special instructions or announcements will appear in the College Bulletin and will be transmitted to the Record and the campus radio station.
- (b) Everyone driving on the campus is responsible for knowing and understanding these rules. Cooperation and compliance with these rules will make the campus a safer place.

§ 562.15 Traffic control.

The parking of vehicles on the roadways of State University of New York College at Buffalo, Erie County, is prohibited unless otherwise designated.

§ 562.16 Responsibility, penalties, and fines for violations.

- (a) Responsibility. The individual in whose name the motor vehicle is registered with the college, and/or the owner thereof if the motor vehicle is not then registered with the college, shall be responsible for any and all penalties and fines for violations, and for any and all liability or damage claims, resulting from the possession, operation and/or parking of the motor vehicle on the premises of the State University College at Buffalo.
- (b) Penalties. Violators of any of the campus traffic and parking rules and regulations will be subject to the issuance of a ticket returnable as directed in section 562.17 of this Part, and also administrative late payment fee(s) if fine is not paid within the prescribed time(s). If the college parking ticket is not paid within the prescribed period of time, a late fee, as approved by the chancellor or designee, will be imposed for the additional processing. Any person who violates any applicable section of the Vehicle and Traffic Law shall be punished in any court having jurisdiction. Unpaid fines shall be deducted from the salary or wages of an offending officer or employee of the university. In the case of students, grades, transcripts and registration may be withheld until all fines are paid.
- (c) Violators with 10 or more parking violations may be subject to revocation of the campus vehicle registration decal and a loss of parking privileges for the balance of the academic year or from future campus vehicle registration until such parking ticket fines along with administrative late payment fees are paid.
- (d) Fines for violations. The penalty for violation of these regulations is as follows:
 - (1) For violation of a handicapped designated space the penalty shall be a \$50 fine.
 - (2) For violation of a fire lane or fire hydrant the penalty shall be a \$[25] 35 fine.
 - (3) For violation requiring an intracampus tow the penalty shall be a \$50 fine. This fine is in addition to a fine of \$25 for violation of parking in a no parking 1am 6am lot.
 - ([3]4) For all other violations the penalty shall be a \$[15] 25 fine.

§ 562.17 Complaints, hearings, appeals.

- (a) A complaint regarding any violation of a campus rule shall be in writing, reciting the time and place of the violation and the title, number or substance of the applicable rule.
 - (1) The complaint must be subscribed by the officer witnessing the violation and attached to the vehicle involved.
 - (2) The complaint shall indicate the amount of the fine assessable for the violation, and advise that if the person charged does not dispute the violation, fines may be paid at the student accounts office of the campus within a period to be prescribed by the college council.
 - (3) The complaint shall recite that a hearing may be requested within a period of time as prescribed by the college council after service of the charges by appearing in person at the [traffic] parking services office.

- (4) The complaint shall recite that, should the alleged violator fail to appear at the time fixed for the hearing or should no hearing be requested within the period as prescribed by the college council in paragraph (3) of this subdivision, the complaint is proved and shall warrant such action as may then be appropriate.
- (5) Three or more unanswered complaints in an 18-month period by the same person, regarding violations of a campus parking rule, shall result in a referral to the New York State Commissioner of Motor Vehicles for review in considering the renewal of an operator's license and/or a motor vehicle registration, and the imposition of a fee as approved by the chancellor, or designee, to meet the administrative costs of such referral.
- (b) The chief administrative officer shall designate a hearing officer or board, not to exceed three persons, to hear complaints for violation of campus traffic and parking rules and regulations enforceable on campus. Such hearing officer or board shall not be bound by the rules of evidence, but may hear or receive any testimony or evidence directly relevant and material to the issues presented.
- (c) A request for a hearing for a violation must be made in writing with the [traffic] <u>parking services</u> office, provided the request is filed within the prescribed period of time as designated on the ticket. Should there be no request during this time period, the complaint is proved and will be considered a denial.
- (d) Each request will be reviewed by the hearing officer or parking appeals board which includes a student, faculty or staff representative, and administrator. This board will meet when necessary to hear requests.
- (e) After such review, or not later than five days thereafter, such hearing officer or board shall file a report. A notice of the decision shall be promptly transmitted to the violator. The report shall include:
 - (1) the name of the appellant;
 - (2) the date the complaint was issued:
 - (3) a concise statement of the facts established on the appeal, based upon the testimony or other evidence offered;
 - (4) the time and place of the appeal:
 - (5) the campus rule violated:
 - (6) the names of all witnesses; and
 - (7) the decision (guilty or not guilty) of the hearing officer or board.
