

Buffalo State Undergraduate Enrollment Trend by Student Type






SUNY Comprehensives Fall 2018 to Fall 2019 Percent Change in New Student Enrollment


Buffalo State Undergraduate First-Year Application Trend










Educational Appropriations per FTE






Unrestricted and Restricted Operating Activities: 2018-19





History of SUNY Budget


- Pre 2008/09: Formula Based Budget Allocation
- RAM (pre 1995), BAP (1995), BAPII (2006)
- Abandoned because data used in formulas became outdated and NYS budget cuts impacted allocations
- Campuses submitted annual enrollment plan for approval
- State operating support provided based primarily on actual enrollment plan

2008/09 to 2012/13: Incremental Budget

- State tax support primarily flat
- Budget reductions in four of the last six years
- Funding for negotiated salary increases
- Rational tuition implemented 2011/12 to 2015/16
- 2013/14: Proposed new resource allocation model; never adopted
- 2014/15: Negotiated salary increases; no funding
- 2016/17: Predictable tuition plan through 2020/21
- 2019/20: Acceleration of support for one-time salary costs in 2018/19










the National Average The Unemployment Rates for Degree-Holders are Below

Unemployment rates by educational attainment, 2017






When Degree-Holders Work, They Earn Far More **Than Their Peers**

Median usual weekly earnings by educational attainment, 2017





Jobs paying at least \$35,000 for young workers or \$45,000 for older workers, by educational requirement






Skills Commonly Associated With a Liberal Arts Education Are Among the Most In-Demand From Employers






Requiring Higher Social or Analytical Skills **Employment Growth Is More Rapid In Occupations**

Percent change in employment, 1980-2015






Annually Than Those With Just a High School Diploma Full-Time Workers With a Bachelor's Earn 74% More






Investing In a Degree Pays Off

by degree and price of college Age at which cumulative earnings of college graduates exceeds those of high school graduates,











Poverty Rates are Three Times Higher for Those With Only a High School Diploma

attainment, 2015 Percent of individuals age 25 and older living in poverty, by educational




College Graduates Are More Likely to Vote





October 29, 2019

ACADEMIC AFFAIRS HIGHLIGHTS

Academic Commons

The College has adopted the Noel-Levitz College Success Inventory, survey, which first-year students will complete. It will provide academic advisers detailed information about each student's academic motivations, areas of risk, and receptivity to specific student services. This will provide advisers with data to make interventions more meaningful and relevant, before a student begins disengaging. The academic advising area is working to develop a new intrusive advising strategy to ensure that all students receive targeted support at critical junctures throughout their first year.

A new online summer engagement program is under development to help students to be more prepared and connected to campus life and academic resources before they even set foot on campus. We are looking into working with Institutional Advancement to scale up the *My Personalized Academic Coach Program* (MyPAC), a collaboration between Student Accessibility Services and the Academic Commons tutoring area, to serve more students. This program pairs students with an academic coach – sort of like an academic "personal trainer" – who meets weekly with each student to help keep them accountable and provide them with assistance in study skills

and time management. Currently the program is limited to students with accommodations through SAS, but there is a waiting list to open it to additional students, as it is in high demand by parents and incoming students alike.

Multiple peer tutors in the Writing Center presented at an international conference on peer tutoring in Columbus, Ohio. The Academic Commons currently employs about 25-30 peer tutors. Peer tutoring is an excellent opportunity for students to develop a meaningful connection to college, professionalize, and gain valuable experience for graduate school and the workplace.

Academic Success

SUNY Performance Improvement funds were granted for two years of retention programming at Buffalo State. As a result, three initiatives were created and have been offered during the 2018-19 and 2019-20 academic years. This Fall semester, the Academic Success Summer Bridge program—a one-credit, one week experience the week before the fall semester began—served approximately 150 students per year and employed about 18 returning students per year, the Academic Success Peer Mentoring program—a year-long program for incoming general admit students—is currently supporting 250 first-year students and employing about 24 continuing students, and supplemental instruction is being offered in eleven classes (that are historically high D, E, W courses) with approximately 250 students enrolled and employing about 13 student staff.

Say Yes

Buffalo State's Say Yes program successfully partnered with Say Yes Buffalo, Buffalo Public Schools, and four other higher education institutions and were awarded a two-year Bill and Melinda Gates Foundation grant in the summer of 2019. As a result of the grant, Buffalo State has added three Say Yes Success Counselors to our staff to work with Say Yes students to address their out-of-class needs and help clear the path for academic success. In addition, the grant has allowed for Buffalo State to institute a mental health clinic on campus that provides additional depth of treatment and psychiatric prescription services to support our students' mental health needs. The grant also calls for the development of high school/college transition curriculum development and enhanced student data sharing to be shared between Buffalo Public Schools and the grant's higher education partners in order to smooth the transition from high school to college. There are currently approximately 550 Say Yes students enrolled at Buffalo State with 180 of those students being first-year students (and 30 of those students having participated in the six-credit, five-week Say Yes Summer Success Academy during the summer of 2019. (Grant amount: just under \$450,000)

New Student Academic Programs

The New Student Academic Programs office coordinated First Year Experience academic course offerings for Buffalo State's nearly 1700 incoming first-year students. The work of this office

included ensuring appropriate seat availability as part of our summer registration process, offering multiple sections of UNC 100: Mastering the Academic Environment where we assisted nearly 700 students in their transition to college with the support of 28 faculty. We also organized 22 Learning Communities and 3 Special Interest Housing options that enrolled over 400 students and have engaged over 32 faculty members in curricular integration and co-curricular activities including the Bengals Dare to Care Day. In addition, the New Student Academic Programs office was the lead organizer for the college's annual First Year Convocation—the annual academic welcome to our community's newest scholars—which included the participation of over 100 faculty/staff and over 1400 first-year students. This office advises the college's chapter of Alpha Lambda Delta, a national first-year honor society for students earning a 3.5 or higher in their first term, which currently has 157 members including 32 Fall 2019 inductees.

Civic and Community Engagement

Community-Engaged Learning: Approximately 1,200 Buffalo State students are involved in efforts to utilize academic learning to address community priorities through 83 different courses taught by 55 faculty members this semester. Over 90 community partners support student learning while also having important projects completed for their organization including nutrition education, photographic supports, dance education, and assessment projects.

Census 2020: A campus-wide committee has been planning efforts to support an accurate Census 2020 count during the upcoming spring semester. Efforts will include strategies to increase student and community response to positively impact federal resources and governmental representation that rely on accurate census numbers.

West Side Promise Neighborhood: Buffalo State demonstrates its' commitment as an anchor institution in the west side of Buffalo through its leadership of the community-driven West Side Promise Neighborhood (WSPN). Supported through a gift from the Rich Family Foundation, WSPN supports youth and families through educational initiatives, community building efforts, and leadership development. The 2019 community leadership cohort graduated from the program in July 2019.

Bengals Dare to Care Day: 720 students, faculty, and staff participated alongside community residents at 40 different locations during Buffalo State's annual Bengals Dare to Care Day. Students cleaned and painted community centers, worked in community gardens, sorted donations, and assisted with neighborhood cleanups during this wonderful demonstration of Buffalo State's commitment as SUNY's urban-engaged campus.



EOP

EOP partnered with the Office of Opportunity Programs and UB/NY GEARUP to sponsor a mini conference Thursday October 24th bringing together 65 Gear UP/Pre-Collegiate students with 85 Buffalo State Juniors and Seniors. We offered graduation prep and career themed workshops for the college students, and college prep/intro to Buff State workshops for the high school students then brought them together to network during dinner with Dr. Steven Peraza from History and Social Studies Education as the keynote. Dean Miller from the graduate school provided the closing.


Anne Frank Project






Muriel A. Honors Program Events

Art Conservation

The Garman Art Conservation Department conducted an in-depth analysis of a School of Rembrandt painting, *Portrait of a Young Man in an Armchair*, owned by the Memorial Art Gallery in Rochester. Professors in the department (Fiona Beckett, JJ Chen, Aaron Shugar and Rebecca Ploeger) and four paintings conservation students conducted intensive imaging and analysis with the department facilities. The research is on-going as the cross sections of the paint are now being mounted and more analysis is done on the samples taken. The goal is to find out more about the painting using the modern technology, including X-radiography, infrared imaging, x-ray fluorescence and cross-sections. Other forms of analysis are also being used (such as x-ray diffraction and Raman spectroscopy) to help identify the pigments and artist working methods. The results will be compared to other contemporary studies done on Rembrandt's paintings and is very timely since this year marks 350 years since Rembrandt's death, and has been coined "The Year of Rembrandt" by the Rijksmuseum,

English

This Summer eighteen CWP faculty received professional development in a variety of High Impact Learning Practices including, Applied Learning, Learning Communities, Digital Supplemental Instruction Modules, and Open Education Resources with support from an array of programs, grants, and initiatives across campus (SUNY AAL/PIF Grant, Center for Teaching and Learning, Title III grant, New Student Success Programs, Arts and Humanities Dean's office). Twenty-nine CWP courses or approximately 580 students were therefore positively impacted with the piloting and application of their projects.

A College Writing Program Committee was formed and comprised of 10 faculty members supported by the Dean's office in Arts and Humanities. So far, the subcommittees that comprise this body have

- explored and mapped out a revised program vision, mission, and learning outcomes that
 better align with BSC's current student demographics and needs while relying on best
 practices and high impact learning strategies. These revisions will be pitched to the CWP
 cohort and English faculty this fall, and the formal IF course proposals will be submitted
 in Spring.
- researched a variety of best practices for the teaching of writing and are currently creating
 professional development materials for their colleagues which will be delivered as a
 cohort workshop at the start of the Spring semester

Higher Education Administration

Launched a new fully online advanced graduate certificate program in assessment in student affairs this fall. The certificate is designed to provide professionals with the necessary skills to become assessment leaders in their higher education community and beyond. It is grounded in the

principles and foundations of data-based decision making, collaborative practice, and reflective learning. It is designed to equip practitioners with the skills to gather information, the ability to understand the nature and value of formal inquiry, and the opportunity to serve as change agents within their institution through assessment.

Faculty Spotlight

MOHAN S. DEVGUN, chair and professor of engineering technology, and ROBERT H. SUMMERS, assistant provost for global engagement, represented Buffalo State at a Study Abroad Fair in Mumbai, India, this summer. A number of students inquired about the college's undergraduate and graduate programs in data science and analytics, engineering technology, and applied economics. In other news, Devgun has been nominated to serve on the Amherst Diversity Council for the current year, and he also serves as president of Sikh Cultural and Educational Society of Western New York in Williamsville.

KIMBERLY A. KLINE, professor of higher education administration, and LAURA H. RAO, director of civic and community engagement, guided 10 students on a three-week study tour to Ukraine, Poland, and Germany this past May—June. The course was focused on civic engagement through an international lens. Students visited Ukraine and Poland to study current social issues that are being addressed by student-led reforms. In addition, students visited a selection of higher education institutions and refugee resettlement areas in Germany in order to gain firsthand knowledge of how the influx of refugees in 2015 resulted in thousands of New Germans who are thriving citizens. The course enhanced students' global understanding through personal, professional, and academic development; exposed students to new cultures and international travel; and allowed students to develop awareness of diverse cultures and their relation to the United States.

AMY B. WILSON, chair and associate professor of higher education administration, and colleagues from Shippensburg University and Eastern Michigan University recently published a book titled Inclusive Supervision in Student Affairs: A Professional Model for Practice (CRC Press, September 2019). The book provides a new, action-oriented model that addresses what supervisors should do to create more inclusive environments for all staff and to help inform socially just practice.

STEPHEN C. BURGESON, lecturer of hospitality and tourism, and SUE C. SIMS, kitchen manager at Campus House, partnered with LYNNE C. SOMMERSTEIN, lecturer of exceptional education and founder/director of the College-Based Transition Program at Buffalo State, and Buffalo Public Schools representatives to offer a non-credit program for students ages 18-23 with significant disabilities who are learning skills in the commercial kitchen at Campus House.

Finance and Management

Divisional Highlights for the College Council, November 5, 2019

DART STREET PROJECT

Since Mayor Brown's February 2019 announcement of the City's intention to enter into a Designated Developer Agreement (DDA) with Buffalo State and the BSCR Corporation for the redevelopment of the City Impound Lot site, we have:

- Arranged for the DDA to be executed between the City of Buffalo and the BSCR Corporation
- Solicited information from key stakeholders that will inform the project Request for Proposal (RFP), currently in development
- Developed and vetted the project vision, workflow, timeline, budget, informational documents and presentations
- Seated a six-member Dart Street Project Advisory Committee
- Developed a detailed list of project team members, participants and stakeholders
- Briefed key constituents including the BSCR Corporation Board of Directors, the campus community, the Foundation Board of Directors, and external stakeholders such as the Riverside Blackrock Alliance
- Completed and advertised the project RFP. Proposals are due November 19, 2019.

During 2019-20 we look forward to progressing through this transformational project by:

- Receiving the proposals and reviewing them with internal and external constituents including campus and community stakeholders, the Dart Street Advisory Committee and the College Council Facilities Committee
- Recommending a concept/developer to the President via the Capital Development Board
- Working with the successful developer to finalize a project plan
- Submitting the project concept for approval by the Buffalo Common Council

EVENTS MANAGEMENT OFFICE

The Events Management Office has completed a soft launch of <u>25Live</u>, the college's web-based event scheduling system. 25Live is a website that can be used for managing spaces, resources and events. *It allows* event planners to search dates and venues and schedule campus space and resources all in one program. 25Live enables automatic posting of scheduled events to e-calendars and displays throughout the campus.

The full launch, scheduled for November, will be announced in the *Daily Bulletin*. Once fully launched, 25LIve will be available to authorized student leaders as well as faculty and staff members.

FACILITIES

PROJECTS RECENTLY COMPLETED

Rockwell Hall

Renovations to the Performing Arts Center included improvements to the auditorium, ticket office, band room and basement corridor. This \$1.18 million project was completed in fall 2019.

Tower 3 Renovation

Renovations to Tower 3 included entrance, lobby and elevator rehabilitation; lounge and laundry room improvements; and updates to student suites. This \$14.75 million refurbishment began in summer 2018 and was completed in summer 2019.

New Turf at Coyer Field

Buffalo State's turf field is used for football, soccer, and lacrosse, as well as for recreational purposes, camps and rentals. This project replaced the turf field, scoreboard, goals and goal posts. During the second part of the project in summer 2020, the six-lane Coyer Field track will be replaced. Total cost of the refurbishments will be \$4.5 million.

PROJECTS IN CONSTRUCTION

Science and Mathematics Complex, Phase 4

Phase 4 will complete this multi-year project with the addition of the spherical, stand-alone

Whitworth Ferguson Planetarium, greenhouse, lecture hall, classrooms, offices and labs. The cost will be \$35.5 million. Fall 2020 classes are planned.

Academic Commons, Butler Library

As part of its Academic Improvement Plan, Buffalo State is <u>co-locating and centralizing academic support services</u> in Butler Library. The resulting Academic Commons will include academic advising, tutoring, the Writing Center, the Math Center, the EOP Academic Center for Excellence, and Student Accessibility Services. Areas of the first and second floors of the library are being reconfigured and upgraded in this \$15.3 million project slated for a spring 2020 completion.

Central Heating Plant Reconstruction, Phase 1

Buffalo State's steam plant is at the end of its life cycle. This project will replace boilers and all associated equipment with new and more efficient versions. This will save costs for fuel, operation and maintenance; reduce harmful emissions and potential for harmful fuel leaks; provide a more reliable source of heat and hot water for the campus; and potentially clear space in the building for other service uses. Construction will begin in October 2019.

Iroquois Drive Reconstruction

This project, phased to occur over two seasons, is reconstructing the roadway, curbs and underground drainage of Iroquois Drive. The concrete retaining wall will be repaired along a portion of the north side. Improvements will include new site lighting, storm water retention and treatment, a continuous sidewalk, high visibility crosswalks, sharrows for bicycles and improvements to the green area on the north side of Moore Complex. Construction on this \$7.9 million renovation began in spring 2019. It is slated for winter 2020/2021 completion.

PROJECTS IN PLANNING AND DESIGN

Classroom Building

The Classroom Building, built in 1972, retains most of its original systems and its space configuration. These no longer meet the needs of our students and faculty. This project will provide collaborative, study and lounge space for students and address the teaching needs of our academic departments. It will also add an identifiable south entrance to the building, increase natural light, improve wayfinding and replace building systems and finishes. It will add sprinklers and increase the

plumbing fixture count. A deep energy retrofit (an energy conservation measure in an existing building that improves building performance) will be addressed. This will be a phased renovation with a total budget of \$78 million.

University Police and Campus Operations Center

Building 50 was built in the 1950s and acquired by the campus in 2003. It was constructed for manufacturing but has been used by Buffalo State as a storage facility. This 92,000 square foot building is in great need of rehabilitation. This renovation will provide appropriately designed space to accommodate University Police and custodial and grounds employees; renovate warehouse and dock space; and create a better link to the main campus pedestrian spine and designated visitor parking areas. This is a \$14.8 million project.

Program Study for Moore Hall

Moore Hall was built as a dining hall to serve Moore Complex and the Towers. Currently the building is being used by the Custodial Services and Property Control and Sustainable Programs Offices, which will relocate to Building 50 once that facility is renovated. Other uses include Moore Complex offices and a lounge for Moore Complex and Tower 1. The intent of the college's facilities and housing master plans is to return Moore Hall to student life use. The campus is performing a program study to determine the best uses for this building. These may include, but are not limited to, food service, multipurpose programming space, lounge space, and a convenience store.

SPONSORED PROGRAM ADMINISTRATION

Research Foundation Cash Position

Between June 2019 and September 2019 the cash position for the Research Foundation/Buffalo State improved from .80 to 1.80. The maximum score possible is 3.

There were several factors that contributed to the improvement, one being a recognition by SUNY that Buffalo State was not solely at fault with the finding on a NYS Department of Health award that resulted in significant fines and penalties charged to the campus. SUNY reimbursed the campus for those costs. There was also improvement in the collection of payments from our sponsors. We are continually looking for ways to improve the campus cash position.

STRATEGIC RESOURCE PLANNING PROCESS

The VPFM continues to lay the foundation for Buffalo State's strategic resource planning process (SRPP). Once launched, the SRPP will link the vision, priorities, people, and physical institution of Buffalo State in a flexible system of evaluation, decision-making and action. It will align resource planning to help Buffalo State achieve its overarching institutional and unit objectives of transparency, accountability and risk management, as well as provide support for accreditation.

The process will be rolled out according to the following schedule:

- FY 2018-19: Assess the current environment and begin to establish the process infrastructure
- FY 2019-20: Complete the infrastructure, including processes systems and reports; and optimize the organization and its resources
- FY 2020-21 and beyond: Launch the Strategic Resource Planning Process; assess and refine processes, systems and reports

These key groups have been initiated and will be integrated into the resource planning process:

<u>Enrollment and Resource Planning Taskforce</u>: The VPFM partnered with VP Malcolm to initiate a taskforce that provides enrollment, fee, tuition, financial aid and other data to support the enrollment and resource planning process.

<u>Capital Development Board</u>: The VPFM partnered with Provost Mayrose to initiate a Board that guides long range campus physical development of buildings, land, landscape and infrastructure.

<u>Multi-Year Energy and Financial Plan Committee</u>: This committee maintains Buffalo State's year-to-year energy financial plan, considering all facets of college utility and energy planning.

Future steps will include developing processes, systems and reports that will lay the groundwork for integrated resource planning. These will include:

- Budget model development and planning
- Enterprise risk management
- Improvements to business services and systems

- Entity/hierarchy structure
- Workforce planning

To keep the campus community apprised of progress on this initiative the VPFM presented to the College Senate in October 2018, February 2019, May 2019 and October 2019. She has also begun to make school-focused presentations about integrated resource planning, starting with a talk to the department chairs and other leaders in the School of Arts and Humanities in May 2019. Presentations to other schools and units will follow in 2019-20.

UNIVERSITY POLICE DEPARTMENT

Annual Security and Fire Safety Report

Buffalo State's <u>Annual Security & Fire Safety Report</u> was published September 30, 2019. The report provides current and prospective students, faculty, and staff members with campus safety information, including crime statistics and procedures to follow to report a crime. The report contains information and statistics for the three previous calendar years regarding crimes that occurred on campus; in certain off-campus buildings or property owned or controlled by Buffalo State; and on public property within, or immediately adjacent to and accessible to, the Buffalo State campus. The report also contains information regarding campus security and personal safety measures such as crime prevention, fire safety, reporting policies, disciplinary procedures, and education and awareness campaigns.

Community Policing Event

The 4th Annual <u>Coffee with a Cop</u> community policing event was held in the Student Union on October 2, 2019. Coffee with a Cop brings police officers and the community members they serve together over coffee to discuss issues and learn more about each other. Attending Coffee with a Cop is an easy way for faculty, staff, and students to get to know the men and women of University Police who serve our campus community.

Emergency Notification System and Outdoor Horn Test

The Annual Emergency Notification System and Outdoor Horn Test was held on October 3, 2019. People who were outdoors during the test heard a series of three loud 60-second horn blasts emanating from the central heating plant. In a real emergency, the horn would sound for a minimum of five full minutes.

In the event of a real alert, members of the campus community who hear the horn should immediately seek shelter and await further instructions communicated via Buff State Alert, e-mail, the Buffalo State website or direct instructions from University Police.

ALUMNI ENGAGEMENT

Jacqueline Vito LoRusso Alumni and Visitor Center: The Alumni and Visitor Center hosted 45 events with 1400 attendees during the period, generating \$3,400 in revenue. Notable events include a celebration of the TFA Visiting Artist Series with Kyle Bradstreet, Sigma Lambda Upsilon Reunion, Kappa Delta Pi Education Society Initiation, Small Business Development Workshop, Introducing New Africana Faculty to Campus and Hustle Aesthetic Fitness Workshop. Outside groups utilizing the Alumni and Visitor Center included Buffalo Film Commission, Community Affairs Forum, SUNY Dean and Directors Retreat, WNY Tech Consortium and WNY Business Leaders Meeting. Campus partners utilizing the space include the Professional Science Master's Program, Admissions, the Office of Finance & Management, Office of Academic Affairs and Intercollegiate Athletics. We currently have 32 events booked through December including the Perinatal Mood & Anxiety Disorders Conference, Education Leadership Symposium, SUNY SCI Training, WNYNET Fall Teachers Conference along with several holiday receptions.

Over 60 alumni have stopped by to visit the new center during the period, and more than 140 have requested their Alumni ID Cards.

Events and Opportunities: The Alumni team engaged approximately 485 alumni at 10 events during the period including two sorority reunions and four athletics team reunions. We also hosted a Class of 1969 Reunion and two other events during Homecoming week.

Alumni Communications: During the 2-month period, the Alumni Engagement team sent 16 unique emails to approximately 53,000 unique recipients with a 24% open rate. Natalie Murphy, the Alumni Communication Manager, added to the "Bengals at Work" series with a profile of alumna Cate Burzynski, '11, a television producer whose credits include *In Pursuit with John Walsh* (Investigation Discovery), *Psychic Kids* (A+E), and *Ink Master* (Paramount Network). We have also finalized the implementation phase to launch the online mentoring platform, PeopleGrove.

DEVELOPMENT

Institutional Support: From July 1, 2018 through October 21, 2019, the BSC Foundation received \$571,151 in institutional support against the annual goal of \$5,000,000.

- The 2019 Golf and Tennis Scholarship Classic, held at Park Country Club in September 2019, generated gross revenue of \$112,440, compared with \$105,248 in 2018.
- The end-of-calendar-year appeal, including mail and online strategies, will launch in November.
- Mr. and Mrs. Robert Lamendola have agreed to co-chair the 2020 Gala, scheduled for Saturday, April 25, 2020.
- The president and Dr. Turner hosted the Scholar-Donor Breakfast on Saturday, October 26, 2019. Total attendance of exceed expectations and we were joined by donors, scholars, family members as well as staff and faculty.

150th Campaign Feasibility Study: To date, 90 feasibility studies have been conducted or scheduled with individuals, corporations and organizations. Several campaign leaders have been identified by campaign participants. Many of these have yet to be interviewed and are scheduled in the coming month. Initial findings and recommendations will be delivered by the end of the calendar year.





REPORT OF THE GOVERNMENTAL RELATIONS COMMITTEE TO THE BUFFALO STATE COLLEGE COUNCIL October 2019

The Governmental Relations committee met Friday, October 25, 2019 at 1:00pm to discuss the agenda for the upcoming year. Attending the meeting were Chairman Linda Dobmeier and Council member Cindy Odom.

The meeting was called to order by Chairman Dobmeier at 1:01pm. The committee discussed the current needs of the campus and a legislative agenda to help meet those needs. An overview of advocacy and outreach efforts at federal, state, and local levels was provided, with emphasis on the need to focus on state-level advocacy.

Chair Dobmeier suggested revising a list of projects and initiatives requiring funding from smaller projects to large scale capital projects in order to prepare for advocacy efforts. A campus facilities committee has reviewed key projects, and a report will be provided to the Government Relations Committee at the next meeting. This capital critical needs list will form the basis for advocacy for SUNY Construction Fund projects. In addition, several policy initiatives will be identified by SUNY for system-wide advocacy. Once the SUNY agenda is known, the committee can finalize an advocacy plan for the coming session.

A follow-up meeting of the committee will be scheduled after the upcoming SUNY Government Relations and Communications Advocacy Summit takes place December 17-18, 2019.
